On September 10, 2007, Minnesota Public Radio ("MPR"), licensee of K245AK, Redwood Falls, MN, requested Special Temporary Authority to operate K245AK at 50% of its authorized power. A copy of that request is attached to this letter.

Minnesota Public Radio ("MPR"), licensee of K245AK, Redwood Falls, MN, hereby requests Special Temporary Authority to operate K245AK at 50% of its authorized power. On August 13, 2007 MPR informed the Commission that MPR had temporarily been operating this facility at approximately 50% of its authorized power since August 9, 2007. MPR has a filter on order but it has not arrived yet from the manufacturer.

We hope to bring this facility up to full power shortly upon receipt of the filter from the manufacturer.

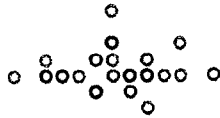

Dear Ms Dortch:

In accordance with 47 CFR 74.1263 (c), Minnesota Public Radio ("MPR"), licensee of K245AK, Redwood Falls, MN, hereby informs the Commission that MPR temporarily and voluntarily decreased the power of K245AK by 50% on August 9, 2007. A filter for the transmitter is on order but is unlikely to be received and put into place within 10 days of August 9th. We are hopeful that the filter will be in place within the next 30 days and that it will allow MPR to return K245AK to full power.
